The Hole-in-the-Rock Foundation will be pleased to answer your questions, make suggestions, and provide the following:

- Day and evening use of the Bluff Fort Historic Site including the log meetinghouse, grounds, restrooms, and use of a full kitchen and eating area with tables/chairs for up to 150 people.
- Handcart rentals at Bluff, Utah.
- Water buffalo rental at Bluff, Utah.
- Use of Camp Stickiety-ta-tudy, our primitive campsite west of Bluff, Utah.

Background Information

Many sections of the Hole-in-the-Rock trail can be visited by small groups, without a permit provided that the group uses individual vehicles and adheres to the BLM's/Park Service usage and group size guidelines. However, groups sponsored by a organization and/or that exceed the BLM/Park Service size limits will require a permit from the appropriate agency (BLM/Park Service). Any group, regardless of size, wishing to pull handcarts will require a BLM permit. Even small groups are responsible to carry out their own waste and provide toilet facilities.

The Hole-in-the-Rock Foundation is pursuing a license from the BLM that would allow the foundation to offer ward and stake groups trekking and camping abilities at select portions of the Hole-in-the-Rock Trail, San Juan County side of the trail only. This would eliminate the need for wards/stakes to obtain their own BLM permits and eliminate the per person charge currently imposed by the BLM for large groups. Until such time as the Hole-in-the-Rock Foundation is licensed to provide these trekking options, the following guidelines apply:

Vehicle accessibility: San Juan Hill – four-wheel drive only. Non four-wheel vehicles can pull the highway and park at the trailhead. There is no ability for city buses to pull off or turn around at the trailhead. City bus pull off accommodations are limited to the Bluff Fort Historic Site and the foundation’s campground.		

<p>Season/Temperatures: Mid summer temperatures typically hover around 100 degrees . There is no shade along the trail or at the foundation’s campground. Due to the temperatures, the ideal trekking time is usually late spring through early summer.</p>		

Hole-in-the-Rock Crevice in Glen Canyon or other trail sites in the Golden Staircase National Monument Kane/Garfield Counties

The Escalante BLM Field Office and the National Park Service are in the process of finalizing a Hole-in-the-Rock road (Escalante to Hole-in-the-Rock) camping and usage guidelines for large groups. When in place, this new guideline will accommodate larger groups (at BLM designated locations) than what is specified below. However, the fee structure will be the same as noted below. Contact the BLM Escalante Field office for details on camping site locations and group size limitations.

<p>required along the last ten miles of the road to the Hole-in-the-Rock. Garfield County has greatly improved the road. As of the spring of 2011, you can make it without four-wheel drive but high ground clearance and good tires are a must. The condition of the road varies with each storm, thus always check on the current road condition.</p>
